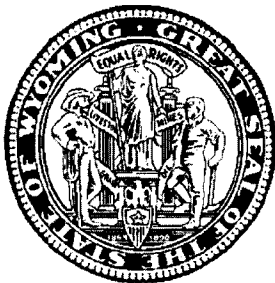

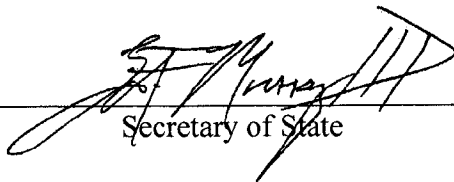

**Article I**

The name of the corporation shall be Intelliquip, Inc. Intelliquip, LLC was formed in Delaware on May 21, 2002. Its conversion to a Wyoming corporation has been approved by Intelliquip, LLC's Manager and a supermajority of its Members, as required by the laws of the jurisdiction of its formation and its governing documents, by written consent.

**Article III**

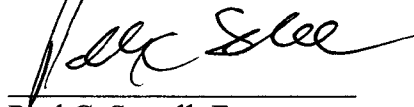

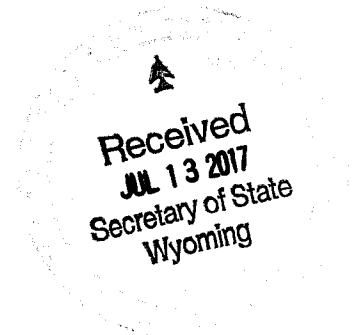
