**TERMINATION AND RELEASE OF
SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This Termination and Release of Security Interest in United States Trademarks (this "Release"), is made as of July 26, 2017, by Royal Bank of Canada, as grantee, in its capacity as agent for certain lenders in connection with the Security Agreement described below (in such capacity, "Grantee") in favor of Viawest, Inc., a Delaware corporation (the "Grantor").

WITNESSETH:

WHEREAS, Grantor entered into a certain Security Interest dated May 20, 2010 (the "Security Agreement") with the Grantee, notice of which was recorded on May 26, 2010 at the United States Patent and Trademark Office at Reel 4213, Frame 0603.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, Grantor granted the Grantee, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in and to Grantor's trademarks registrations and trademark applications, including those listed in **Schedule A**, all Proceeds and products of its trademark registrations and trademark applications, the goodwill of the businesses with which the trademark registrations and trademark applications are associated and all causes of action arising prior to or after May 26, 2010, for infringement of any of its trademark registrations and trademark applications or unfair competition regarding the same (the assets identified on Schedule A, collectively, the "Marks").


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Marks listed in **Schedule A**, as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Grantee, for itself and on behalf of the lenders for which it is acting as agent in association with the Security Interest, without representation, warranty or recourse, hereby releases, terminates and discharges any and all of its right, title and interest in the Marks and assigns, transfers and conveys to Grantor such right, title and interest, including the Security Interest therein.
