## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made as of the 19<sup>th</sup> day of July 2017, by HERCULES TECHNOLOGY III, L.P. ("Assignor") in favor of INSTAMED COMMUNICATIONS, LLC, a Pennsylvania limited liability company ("Assignee").

WHEREAS, Assignee and Assignor entered into (i) that certain Loan and Security Agreement, dated as of September 30, 2013, by, among others, Assignee, as borrower, and Assignor (as assignee of Hercules Technology II, L.P.), as lender (as amended, supplemented, or otherwise modified from time to time, the "Loan and Security Agreement") and (ii) that certain Intellectual Property Security Agreement, dated as of September 30, 2013, by and between Assignee, as grantor, and Assignor, as Lender (as amended, supplemented, or otherwise modified from time to time, the "IP Security Agreement" and with the Loan and Security Agreement, collectively, the "Agreements"), for the purpose of securing certain obligations of Assignee to Assignor upon the terms and conditions set forth in the Agreements;

WHEREAS, pursuant to the Agreements, Assignee granted the Assignor a security interest in all of the Copyrights, Patents, Trademarks and Mask Works (as defined in the Agreements), including, without limitation, the Copyrights, Patents, Trademarks and Mask Works, identified on Exhibits A, B, C, and D, attached hereto (collectively hereinafter the "Intellectual Property"), and pledged and mortgaged (but did not transfer title to) the Intellectual Property to Assignor;

WHEREAS, all of the indebtedness and other obligations secured by the Assignor's security interest in the Intellectual Property have been repaid in their entirety, and the Assignor is therefore obligated to release its security interest in the Intellectual Property;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 031315, Frame 0513 on September 30, 2013 with respect to the Patents;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005120, Frame 0689 on September 30, 2013 with respect to the Trademarks; and

WHEREAS, the Assignee has requested that the Assignor enter into this Release in order to effectuate, evidence and record the release and reassignment to the Assignee of any and all right, title and interest the Assignor may have in the Intellectual Property pursuant to the Agreements.

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Agreements:

The Assignor, on behalf of itself and its successors, legal representatives and assigns, hereby terminates the IP Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Agreements in any right, title and interest of Assignee, and reassigns to the Assignee any and all right, title and interest that it may have in, to and under the Intellectual Property, including without limitation, the Copyrights, Patents, Trademarks and Mask Works, identified on Exhibits A, B, C, and D attached hereto, effective as of the date set forth above.

Assignor hereby agrees to execute such further instruments and documents and perform such further acts as Assignee may deem necessary to secure to Assignee the rights herein conveyed.


