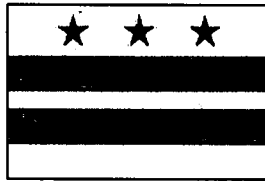

**ARTICLES OF AMENDMENT
OF THE
ARTICLES OF INCORPORATION
OF
2ARMADILLOS CO.**

Under the provisions of the Title 29 of D.C. Code (Business Organizations Act), the domestic filing entity listed below hereby applies for a Certificate of Amendment and for that purpose submits the statement below. 2Armadillos Co. (the "Corporation"), a corporation duly organized and existing under the law of the District of Columbia, does, by James Edgerton, its President, under its corporate seal, hereby certify that:

A. The original Articles of Incorporation of the Corporation was filed with the Department of Consumer and Regulatory Affairs, Corporations Division of the District of Columbia on May 1, 2013.

B. The Board of Directors of the Corporation found that the following proposed amendment of the Articles of Incorporation of the Corporation was advisable and in the best interests of the Corporation, authorized and approved such amendment, and directed that the following proposed amendment be submitted for consideration and action thereon by the shareholders of the Corporation:

1. Article FIRST of the Articles of Incorporation of the Corporation shall be deleted in its entirety and the following shall be substituted in lieu thereof:

"FIRST: The name of the corporation is "Watussee Foods Co.""

2. Article SECOND of the Articles of Incorporation of the Corporation shall be deleted in its entirety and the following shall be substituted in lieu thereof:

SECOND:

A. Authorized Shares. The total number of shares of stock which the Corporation shall have authority to issue is Two Million (2,000,000) shares of Common Stock, par value \$0.0001 (the "Common Stock")."


C. The foregoing amendments of the Articles of Incorporation of the Corporation were duly adopted by the holders of a requisite number of the outstanding shares of capital stock of the Corporation entitled to vote thereon in accordance with the Business Corporation Act of

the District of Columbia and the Articles of Incorporation of the Corporation, as in effect immediately prior to the filing of these Articles of Amendment.
