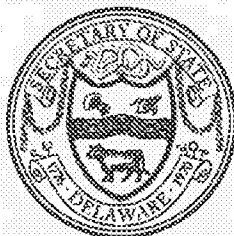



An agreement and plan of merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the provisions of subchapter (c) of Section 251 and Section 252, as applicable, of the General Corporation Law of the State of Delaware.

3. Name of Surviving Corporation. The corporation surviving the merger is THE CORTLAND COMPANIES, INC., a Delaware corporation (the "Surviving Corporation").

4. Certificate of Incorporation of Surviving Corporation. The Certificate of Incorporation of the Surviving Corporation, as in effect on the date of the merger provided for in this Certificate, shall continue in full force and effect as the Certificate of Incorporation of the corporation surviving the merger.

5. Stock. The authorized capital stock and par value of (i) Cortland Cable Company, Inc., a New York corporation, is 200 shares of Common Stock, no par value per share and (ii) Viking Rope Corporation, a Washington corporation, is 100,000 shares of Common Stock, no par value per share.
