**FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT**

THIS FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT (the "Amendment"), is dated as of July 21, 2017, and entered into by and among **Roseburg Forest Products Co.**, an Oregon corporation, ("RFP"), **Roseburg Forest Products South Limited Partnership**, an Oregon limited partnership ("RFPS"), **RLC Industries Co.**, an Oregon corporation ("Parent"), **RFP Composites LLC**, an Oregon limited liability company ("Composites"), **Roseburg International Co.**, a Nevada corporation ("International") and together with RFP, RFPS, Parent, and Composites, each a "Grantor" and collectively, the "Grantors") and BANK OF AMERICA, N.A., as Agent (in such capacity together with its successors and assigns in such capacity, "Grantee").

RECITALS

A. RFP and RFPS, the lenders party thereto, and Grantee are parties to that certain Loan and Security Agreement dated March 31, 2011 (as amended, modified, supplemented or restated from time to time, the "Original Loan Agreement").

B. To induce Grantee to provide the financial accommodations described in the Original Loan Agreement, Grantors, **Scott Timber Co.**, an Oregon corporation ("Scott"), and Grantee entered into that certain Trademark Security Agreement, dated as of March 31, 2011 (as recorded on April 7, 2011 with the United States Patent and Trademark Office at REEL/FRAME 4516/0883 and as amended, modified, supplemented or restated from time to time, the "Agreement").

C. RFP and RFPS have requested that Grantee amend and restate the Original Loan Agreement by executing that certain Amended and Restated Loan and Security Agreement, dated as of the date hereof, by and among RFP, RFPS, the lenders signatory thereto, and Grantee (the "Amended and Restated Loan Agreement"). Capitalized terms used herein have the meanings given to them in the Amended and Restated Loan Agreement unless otherwise specified.

D. To induce Grantee to provide the financial accommodations described in the Amended and Restated Loan Agreement, Grantors have requested that Grantee modify and amend certain terms of the Agreement as set forth herein.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements herein contained, it is agreed as follows:

1. Amendments to the Agreement.

(a) As of the date hereof, Scott shall be released and discharged from its obligations as a Grantor and shall no longer be a party to the Agreement. .

(b) Schedule A to the Agreement is hereby supplemented by adding the trademark registrations and trademark applications set forth on Schedule A hereto ("New Trademarks"), and the New Trademarks shall be deemed Trademarks (as defined in the Agreement) thereunder.

2. No Other Changes. Except as modified by this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect are hereby ratified and reaffirmed by Grantors.

3. Counterparts. This Amendment may be executed in any number of counterparts, each of


which when so executed and delivered shall be deemed an original and all of which counterparts, taken together, shall constitute one and the same instrument.
