WITNESSETH

WHEREAS, DEXTER AXLE COMPANY, a Delaware corporation (the "Grantor") is a party to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Secured Party that certain (i) Grant of Patent Security Interest, dated as of December 30, 2015 and recorded with the United States Patent and Trademark Office ("USPTO") on December 30, 2015 at Reel/Frame No. 37387/0935 (the "Patent Security Agreement"), (ii) Grant of Trademark Security Interest, dated as of December 30, 2015 and recorded with the USPTO on December 30, 2015 at Reel/Frame No. 5700/0009 (the "Trademark Security Agreement"), and (iii) Grant of Copyright Security Interest, dated as of December 30, 2015 and mailed to the U.S. Copyright Office ("USCO") on January 6, 2016 for recordation (the "Copyright Security Agreement" and together with the Patent Security Agreement and the Trademark Security Agreement, the "Intellectual Property Security Agreements"), pursuant to which the Grantor granted to the Secured Party a security interest in all of its right, title and interest in and to the Patent Collateral (as defined in the Patent Security Agreement), Trademark Collateral (as defined in the Trademark Security Agreement), and Copyright Collateral (as defined in the Copyright Security Agreement); and


WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Intellectual Property Security Agreements have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Secured Party release its security interest in all of its right, title and interest in and to the Patent Collateral, Trademark Collateral, and Copyright Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in and to the Patent Collateral, Trademark Collateral, and Copyright Collateral, including the patents, patent applications, trademark registrations, and copyright registrations set forth in Schedule I attached hereto and incorporated herein by reference. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Secured Party may have obtained in, to and under the Patent Collateral, Trademark Collateral, and Copyright Collateral under the Intellectual Property Security Agreements and the Security Agreement. The Secured Party hereby authorizes the Grantor or its authorized representative to record this Release with the USPTO and USCO, as applicable, and/or otherwise record or file this Release in the applicable governmental office or agency.


