**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release"), dated as of July 24, 2017, is made by BNP PARIBAS, as Administrative Agent for the Lenders (the "Secured Party"), pursuant to the Credit Agreement, dated as of December 30, 2015, (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Credit Agreement") and the Security Agreement, dated as of December 30, 2015, (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Security Agreement").

WITNESSETH

WHEREAS, QUALITY TRAILER PRODUCTS, LP, a Texas limited partnership (the "Grantor") is a party to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Secured Party that certain Grant of Trademark Security Interest, dated as of October 7, 2016 and recorded with the United States Patent and Trademark Office on October 7, 2016 at Reel/Frame No. 5897/0876 (the "Trademark Security Agreement"), pursuant to which the Grantor granted to the Secured Party a security interest in all of its right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Trademark Security Agreement has been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Secured Party release its security interest in all of its right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in and to the Trademark Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Secured Party may have obtained in, to and under the Trademark Collateral under the Trademark Security Agreement and the Security Agreement. The Secured Party hereby authorizes the Grantor or its authorized representative to record this Release with the USPTO and/or otherwise record or file this Release in the applicable governmental office or agency.
