2. Recordation and Further Actions. Assignor authorizes the Commissioner of Patents and Trademarks and any other governmental officials or bodies (e.g. Domain Name Registrars) to record and register this Assignment upon request by Assignee. Assignor shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure and/or facilitate that the Intellectual Property is properly assigned to Assignee, or any assignee or successor thereto, as may be reasonably necessary to effect the purpose of this Assignment and carry out its provisions. Should Assignor fail to comply with the provisions of this section, Assignor hereby irrevocably designates and appoints Assignee, as Assignor's attorney-in-fact with authority to take such actions and to execute and deliver such documents or instruments on Assignor's behalf and to make appropriate dispositions thereof as are necessary to vest the ownership of the Intellectual Property in and to the Assignee.
