RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”) is made as of July 31, 2017, by **FIFTH THIRD BANK**, as administrative agent (in such capacity, the “Administrative Agent”), in favor of **DUNCAN SOLUTIONS, INC., PROFESSIONAL ACCOUNT MANAGEMENT, LLC** and **LAW ENFORCEMENT SYSTEMS, LLC** (collectively, the “Grantors” and individually, each, a “Grantor”).

W I T N E S S E T H

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of February 5, 2016 (the “Trademark Security Agreement”), the Grantors granted the Administrative Agent a security interest in and to the Registered Trademarks (as defined therein), including the registered U.S. trademarks and applications identified on Schedule 1 attached hereto, and all recordings and registrations thereof and applications therefor, all renewals and extensions thereof, all rights corresponding thereto, all goodwill associated therewith or symbolized thereby, and all proceeds of the foregoing, including, without limitation, all general intangibles embodying, incorporating, evidencing or otherwise relating or pertaining to the Registered Trademarks (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on February 8, 2016 at Reel 5726, Frame 0455;

WHEREAS, each Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral; and

WHEREAS, the Administrative Agent, on behalf of itself, the Lenders and the Secured Parties, desires to grant to the Grantors a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration previously tendered by the Grantors, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself, the Lenders and the Secured Parties, does hereby terminate the Trademark Security Agreement and assign, terminate, release and discharge the entirety of the security interest in the Trademark Collateral and reassigns to the Grantors any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademark Collateral and associated common law rights and goodwill appurtenant thereto, and further agrees that it shall execute all other documents and do all other acts necessary to relinquish, confirm, effectuate and record this Release and each Grantor’s right, title and interest in and to the Trademark Collateral.
