

In accordance with the aforesaid agreements, Assignor hereby grants to Agent a security interest in all right, title and interest that Assignor has in and to the trademarks/service marks, trade names, and all other intellectual property rights associated with the marks set forth in Exhibit "A" which is annexed hereto and incorporated herein, and all common law rights in the foregoing, and all goodwill associated therewith.


