## IP ASSIGNMENT AGREEMENT

This IP Assignment Agreement (this “**Agreement**”), dated as of July 3, 2017, is entered into by and between Clayton Properties Group II, Inc., a Colorado corporation (“**Buyer**”), on the one hand, and Oakwood Homes LLC, a Colorado limited liability company (the “**Seller**”), on the other hand. Buyer and the Seller are each referred to in this Agreement as a “**Party**” and, together, the “**Parties**”.

### RECITALS

A. The Parties, among others, entered into that certain Asset Purchase Agreement, dated as of July 3, 2017 (the “**Purchase Agreement**”), pursuant to which, among other things, the Seller agreed to sell, convey, grant, assign, transfer, and deliver to Buyer, and Buyer agreed to purchase and acquire from the Seller, free and clear of all Encumbrances (other than the Permitted Encumbrances), all of the Seller’s right, title, and interest in and to the Seller/Sub Intellectual Property.

B. The Parties are entering into this Agreement in order to evidence the sale, conveyance, grant, assignment, transfer, and delivery of the Seller Intellectual Property by the Seller to Buyer.

### AGREEMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

1. Pursuant to the terms of the Purchase Agreement, the Seller hereby sells, conveys, grants, assigns, transfers, and delivers to Buyer, and Buyer hereby purchases and acquires from the Seller, free and clear of all Encumbrances (other than the Permitted Encumbrances), all of the Seller’s right, title, and interest in and to (i) the Seller/Sub Intellectual Property, (ii) the goodwill of the Business symbolized by the Seller/Sub Intellectual Property, (iii) any Proceeding related to the Seller/Sub Intellectual Property, whether accruing before, on, or after the Closing Date, including all rights to and claims for damages, restitution, and injunctive relief and other legal and equitable relief for past, present, and future infringement thereof, and (iv) any common law rights of the Seller to the Seller/Sub Intellectual Property.

2. The Seller hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office and/or the United States Copyright Office, as applicable, to record the assignment of any trademark or copyright registrations and applications set forth on Exhibit A, of the Seller to Buyer.

3. The Seller shall execute and deliver, at the reasonable request of Buyer, such further instruments of sale, conveyance, grant, assignment, transfer, and delivery, and take such other actions, as Buyer reasonably requests to effectuate, confirm, perform, or carry out the terms or provisions of this Agreement.

4. The terms of the Purchase Agreement, including the Parties’ representations, warranties, covenants, agreements, and indemnities, are not superseded by this Agreement, but remain in full force and effect to the full extent provided in the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms of this Agreement, the terms of the Purchase Agreement are to govern.

5. This Agreement, as well as all matters in dispute among the Parties, whether arising from or relating to this Agreement or arising from or relating to alleged extra-contractual facts prior to, during, or subsequent to this Agreement, including fraud, misrepresentation, negligence, or any other alleged tort

or violation of this Agreement, regardless of the legal theory upon which such matter is asserted, are to be governed by, construed under, and enforced in accordance with the Legal Requirements of the State of Delaware without regard to any conflicts of laws principles that would require the application of any other Legal Requirements.

6. Any dispute, controversy or question of interpretation arising under, out of, in connection with or in relation to this Agreement or any amendments hereof, or any breach or default hereunder, shall be litigated exclusively in the state courts located in the Delaware Court of Chancery (and if the Delaware Court of Chancery shall be unavailable, any Delaware State court and the Federal court of the United States of America sitting in the State of Delaware). Each of the Parties hereby irrevocably consents and submits to the exclusive jurisdiction and venue of any such court and each of the Parties hereby irrevocably waives all objections and defenses that such Party may have based on improper venue or forum non conveniens to the maintenance of any such action in any such court.

7. THE PARTIES HEREBY WAIVE ANY RIGHT TO TRIAL BY JURY IN ANY PROCEEDING ARISING OUT OF OR IN ANY WAY PERTAINING TO THIS AGREEMENT, THE OTHER TRANSACTION DOCUMENTS, OR THE TRANSACTIONS, WHETHER NOW OR HEREAFTER ARISING, AND WHETHER SOUNDING IN CONTRACT, TORT, OR OTHERWISE. ANY PARTY IS PERMITTED TO FILE A COPY OF THIS SECTION 7 WITH ANY COURT AS WRITTEN EVIDENCE OF THE KNOWING, VOLUNTARY, AND BARGAINED AGREEMENT AMONG THE PARTIES TO IRREVOCABLY WAIVE TRIAL BY JURY, AND THAT ANY PROCEEDING WHATSOEVER AMONG THE PARTIES RELATING TO THIS AGREEMENT, THE OTHER TRANSACTION DOCUMENTS, OR THE TRANSACTIONS IS INSTEAD TO BE TRIED IN A COURT OF COMPETENT JURISDICTION BY A JUDGE SITTING WITHOUT A JURY.

8. The Parties are permitted to execute this Agreement in one or more counterparts, each of such counterparts is to be deemed to be an original copy of this Agreement and all of which, when taken together, are to be deemed to constitute one and the same agreement. The exchange of copies of this Agreement and of signature pages by facsimile, electronic mail, or other means of electronic transmission (including pdf or any electronic signature complying with the U.S. federal ESIGN Act of 2000, e.g., www.docusign.com) is to constitute effective execution and delivery of this Agreement as to the Parties. Signatures of the Parties transmitted by facsimile, electronic mail, or other means of electronic transmission (including pdf or any electronic signature complying with the U.S. federal ESIGN Act of 2000, e.g., www.docusign.com) are to be deemed to be their original signatures for all purposes.

9. The recitals to this Agreement are hereby incorporated into and made a part of this Agreement by reference to such recitals. Capitalized terms used in this Agreement, but not defined in this Agreement, have the meanings given to such terms in the Purchase Agreement.
