TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is made by and between Saratoga Harness Racing, Inc., a corporation organized under the laws of the State of New York, with an address of 342 Jefferson Street, Saratoga Springs, NY 12866 ("Assignor"), and Saratoga Casino Holdings LLC, a Delaware limited liability company, with an address of 342 Jefferson Street, Saratoga Springs, NY 12866 ("Assignee"). Assignor and Assignee sometimes referred to herein individually as a "Party" and collectively as the "Parties").

WHEREAS, Assignor is the owner of U.S. Trademark Registration Numbers 4718256 and 4732067 for the marks SARATOGA CASINO BLACK HAWK and SARATOGA CASINO BLACK HAWK & design (collectively the "Trademarks").

WHEREAS, Assignee wishes to acquire all right title and interest in said Trademarks.

WHEREAS, Assignor is interesting in assigning said Trademarks to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency is hereby acknowledged, Assignor and Assignee, each intending to be legally bound hereby agree as follows:

1. Assignor hereby transfers, conveys and assigns the Trademarks under U.S. Registration Numbers 4718256 and 4732067 and all goodwill associated therewith, to Assignee.
2. Assignee accepts such transfer, conveyance and assignment from Assignor.
3. Assignor hereby authorizes and requests the Commission of the United States Patent and Trademark Office, and any other corresponding entity or agency in any applicable state or federal jurisdiction, as applicable, to record Assignee as the assignee and owner of the Trademarks.
4. Assignor will provide to Assignee, all such other documents as may be reasonable necessary to effectuate the purposes of this Agreement.
5. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, and all which together shall constitute one and the same instrument. A Party may deliver this Agreement by transmitting a facsimile or other


electronic signature to the other Party, which facsimile or other electronic signature shall be deemed an original for all purposes.

6. The terms and provisions of this Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.


