## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made as of August 2, 2017 ("Effective Date") by HEALTHCARE ROYALTY PARTNERS III, L.P., a Delaware limited partnership, in its capacity as a secured party ("Grantee"), in favor of NOVUM PHARMA, LLC, a Delaware limited liability company ("Grantor"). All capitalized terms used in this Release which are not defined herein shall have the same meanings given such terms in that certain Trademark Security Agreement by and between the parties.

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated March 1, 2016 ("Trademark Security Agreement"), Grantor assigned, transferred and conveyed to Grantee, a security interest in all of Grantor's rights, title and interests in and to the collateral listed on Schedule I hereto (the "Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 2, 2016 at Reel 005743, Frame 0907; and

WHEREAS, Grantee has consented to the release of the lien and of its interests in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee hereby terminates and releases any and all of its liens on and security interests in the Collateral.
2. To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's rights, title and interests, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Collateral.
3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release.
