TERMINATION OF SECURITY INTEREST IN TRADEMARK

This TERMINATION OF SECURITY INTEREST IN TRADEMARK (this "Termination"), effective as of July 19, 2017, is made by PNC Bank, National Association (the "Secured Party"), with respect to the security interest granted to it by Riverbend Foods LLC, a Delaware limited liability company ("Grantor"), in the Released Trademark (defined below).

WHEREAS, reference is made to that certain Revolving Credit and Security Agreement, dated as of May 22, 2017 (the "Credit Agreement"), by and among the Secured Party, the Grantor and the other parties named therein;

WHEREAS, pursuant to the terms and conditions of the Credit Agreement, the Grantor entered into that certain Grant of a Security Interest – Trademarks, dated as of May 22, 2017 (the "Trademark Security Agreement"), pursuant to which the Grantor granted to the Secured Party, for the benefit of the Secured Parties, a continuing security interest in any and all right, title and interest of Grantor in, to and under all of the Grantor's Trademarks (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on June 14, 2017, at Reel 006084, Frame 0206;

WHEREAS, the Trademarks identified in the Trademark Security Agreement included the trademark "H HILLCREEK and design" registered with the USPTO, Registration No. 4173078 (herein referred to as the "Released Trademark"); and

WHEREAS, upon the request of the Grantor, the Secured Party has agreed to release and discharge fully its security interest in the Released Trademark in accordance with the terms of the Credit Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby releases and discharges fully and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the Released Trademark, without recourse or representation or warranty, express or implied. Secured Party hereby authorizes the recordation of this Termination with the USPTO to place on record the release of the security interest in the Released Trademark.

This Termination shall, in accordance with Section 5-1401 of the General Obligations Law of the State of New York, be governed by and construed in accordance with the laws of the State of New York applied to contracts to be performed wholly within the State of New York.
