## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Agreement") is entered into at Jenkintown, Pennsylvania, as of July 28, 2017, between **CLARENCE J. VENNE, LLC**, a Delaware limited liability company, with an address at 7900 N. Radcliffe Street, Bristol, PA 19007; **GAMEMARK PRODUCTS, INC.**, a Delaware corporation, with an address at 7900 N. Radcliffe Street, Bristol, PA 19007; and **JEFFREY FISCHER**, an adult individual, with an address at 804 Meadowood Lane, Warminster, PA 18974 (collectively, the "Borrowers"), and **CITIZENS BANK OF PENNSYLVANIA**, with an address of One Citizens Plaza, Providence, RI 02903 (the "Bank").

The Borrower, Clarence J. Venne, LLC, is the owner of certain Patents and Trademarks, as identified in Exhibit "A" attached hereto and made a part hereof, (the "Intellectual Property" and at times the "Collateral") and as a condition of the loan approval and with the consent of GameMark Products, Inc., and Jeffrey Fischer, who are co-borrowers, the loan in the amount of \$5,000,000.00 of this same date, will be secured by the Intellectual Property.

The loan secured by this lien was made under a U.S. Small Business Administration ("SBA") nationwide program which uses tax dollars to assist small business owners. If the United States is seeking to enforce this document, then under SBA regulations:

(a) When SBA is the holder of the Note, this Agreement and all documents evidencing or securing the Loan will be construed in accordance with federal law.

(b) The Bank or SBA may use local law or procedures for purposes such as filing papers, recording documents, giving notice, foreclosing liens, and other purposes. By using these procedures, SBA does not waive any federal immunity from local or state control, penalty, tax or liability. No debtor or guarantor may claim or assert against SBA any local or state law to deny any obligation of Borrowers, or defeat any claim of SBA with respect to the Loan. Any clause in this Agreement requiring arbitration is not enforceable when SBA is the holder of the Note secured by this Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrowers agree as follows:

### **1. GRANT OF SECURITY**

The Borrowers hereby pledge and grant to the Bank a first lien on and security interest in and to all of such Borrowers' right, title and interest in, to and under the Intellectual Property as Collateral for the loan, which shall include those Patents and Trademarks set forth in Exhibit "A" as well as all future acquired, obtained, developed and/or registered intellectual property generally as set forth below:

(a) all United States patents, patent applications, and certificates of inventions industrial designs set forth in Exhibit A hereto as may be supplemented from time

to time by supplements to the this Agreement together with all reissues, divisions, continuations, continuations-in-part, extensions, amendments and re-examinations thereof, all inventions both described and claimed therein, and all rights therein provided by laws, international treaties or conventions (the "Patents");

(b) all United States registrations and applications for trademarks, service mark, service marks, certification marks, collective marks, trade dress, slogans, logos, Internet domain names, product configurations, trade names, business names, corporate names and other source identifiers, whether or not registered, whether statutory or common law, whether currently in use or not, including, without limitation, all common law rights and registrations and applications for registration thereof, , and all other marks registered in the U.S. Patent and Trademark Office or in any office or agency of any State or Territory of the United States of any foreign county (but excluding any United States intent-to-use trademark application prior to the filing and acceptance of a Statement of Use or an Amendment to allege use in connection therewith to the extent that a valid security interest may not be taken in such an intent-to-use trademark application under Applicable Law), and all rights therein provided by laws, international treaties or conventions or other Applicable Laws with respect to the use of any of the foregoing, all reissues, extensions, continuations and renewals and amendments of any of the foregoing, together in each case with the goodwill of the business connected therewith and symbolized thereby, and all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Borrowers as may be obtained, developed or otherwise acquired hereafter from time to time (the "Trademarks");

(c) all copyrights, copyright applications, copyright registrations and like protections in each work of authorship, whether statutory or under common law, whether published or unpublished, registered or recorded in the United States whether published or unpublished and all mask works (as such term is defined in 17 U.S.C. Section 901, et seq.), all rights and privileges arising under all Applicable Law with respect to such copyrights, any renewals or extensions thereof, all copyrights of works derived from such copyrights, including, without limitation, the copyright registrations and copyright applications, together with all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Borrowers accruing thereunder or pertaining thereto (the "Copyrights");

(d) any and all payments, damages, claims for damages for past, present and future infringement, misappropriation or breach with respect to the Patents, Trademarks and Copyrights, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(e) all income, fees, royalties and proceeds (now or hereafter due and/or payable) of, collateral for and supporting obligations relating to, any and all of the foregoing.

## 2. RECORDATION

The Borrowers authorize and request that the Register of Copyrights, the Commissioner of Patents and Trademarks and any other applicable government officer record this IP Security Agreement.

## 3. TERMINATION

Upon the latest of the payment in full in cash of the Secured Obligations including the Guarantees, and the termination or expiration of all Secured Obligations including the Guarantees under the Indenture Documents, the pledge, assignment and security interest granted hereby shall terminate and all rights to the Collateral shall revert to the applicable Grantor.

## 4. EXECUTION IN COUNTERPARTS

This Agreement or any amendment hereto may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement by telecopier or electronic mail shall be effective as delivery of an original executed counterpart of this Agreement or any amendment hereto.

## 5. GRANTS, RIGHTS AND REMEDIES

This Agreement has been entered into in conjunction with the provisions of the Loan and Security Agreement entered into between the parties dated this same date, being part of the parties Loan Documents as defined therein. Each Borrower does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of the Loan Documents as well as the terms and provisions thereof are incorporated herein by reference as if fully set forth herein including the right to confess judgment. In the event that any provision of this Agreement is deemed to conflict with the Loan Documents, the specific provisions of the Loan and Security Agreement and Note shall govern.

## 6. GOVERNING LAW

This Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania.


