**RELEASE UNDER  
TRADEMARK SECURITY AGREEMENT**

THIS RELEASE UNDER TRADEMARK SECURITY AGREEMENT (“Release”) is made as of August 3, 2017, by and among Tender Greens Holdings, LLC, a Delaware limited liability company (“Holdings”), B&W Quality Growers, LLC, a Florida limited liability company (“B&W” and together with Holdings, the “Grantors”), and Cadence Bank, N.A., a national banking corporation, as agent (in such capacity, “Agent”) for the lenders (“Lenders”).

Agent and Grantors previously entered into a Trademark Security Agreement dated as of January 23, 2015 and recorded on February 4, 2015 in the United States Patent and Trademark Office at Reel 5455, Frame 0515 (the “Trademark Security Agreement”), pursuant to which, among other things, each Grantor granted to Agent, for the benefit of Agent and Lenders, a security interest in the “Trademark Collateral” as defined therein to secure its obligations to Agent and Lenders under the Credit Agreement (as defined therein).

NOW, THEREFORE, in consideration of the promises and of the mutual covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

**AGREEMENT**

1. Release of Trademark Collateral. Agent hereby releases its lien, security interest and all other rights on the Trademarks, applications and all other intellectual property rights listed in Appendix A hereto, and in all of the Grantors’ rights, title and interest in, to and under the Trademark Collateral as defined in the Trademark Security Agreement, the Credit Agreement (as defined in the Trademark Security Agreement), and all other documents or instruments executed and delivered pursuant thereto granting or evidencing a lien in favor of Agent, for the benefit of Lenders, and any right, title or interest of Agent therein shall hereby cease. Agent shall take all reasonable steps, including the recordation or filing of such instruments or documents as shall be necessary to document or evidence the release by Agent of its lien on the Trademark Collateral. Each Grantor shall execute and deliver such instruments or documents as shall be reasonably necessary with respect thereto and shall reimburse Agent for all costs (including reasonable attorneys’ fees) with respect to such documents and the filing or recordation thereof with any governmental agency or jurisdiction as required to document or evidence such release and termination of Agent’s lien on the Trademark Collateral.

2. Counterpart. This Release may be executed in identical counterpart copies, each of which shall be an original, but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Release by facsimile or electronic transmission shall be effective as delivery of a manually executed counterpart thereof.




