**RELEASE OF SECURITY INTEREST IN
PATENTS, TRADEMARKS AND COPYRIGHTS**

This **RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS** (this "*Release*") is granted as of August 3, 2017, by **PNC BANK, NATIONAL ASSOCIATION**, as Administrative Agent (the "*Administrative Agent*"), in favor of **STRACK AND VAN TIL SUPER MARKET, INC.**, an Indiana corporation, and **SVT, LLC**, an Indiana limited liability company, (each a "*Pledgor*" and collectively, the "*Pledgors*").

WHEREAS, Pledgors request that Administrative Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of each Pledgor in, to and under all of the trademarks and trademark applications (collectively, the "*Released Trademarks*") identified on Schedule I hereto; and

WHEREAS, Pledgors request that the Administrative Agent provide a document suitable for recording in the USPTO to evidence the release of the Administrative Agent's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. releases, terminates and discharges all liens and security interests in each Pledgor's right, title and interest in, to and under the Released Trademarks, and all goodwill associated therewith, including, without limitation, the Released Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Release be recorded at the USPTO.

Notwithstanding anything herein to the contrary, this Release is made only with respect to the Pledgors identified herein and shall not terminate the Agreement or release Agent's security interests in and liens on any Patents, Trademarks and Copyrights of any party to the Agreement other than the Pledgors identified herein.
