TRADEMARK ASSIGNMENT

1. Assignor hereby assigns to Assignee all of their interests in and to the Pending Trademark Applications and all of the business plans and intentions developed, prepared, planned, and put in place, and all of the goodwill associated with, and identified in, the Pending Trademark Applications.
2. In conjunction with the transfer of Assignor's interests in the Pending Trademark Applications to Assignee, Assignors hereby assigns, transfers, and otherwise conveys to Assignee all right, title, and interest in and to all claims, demands and causes of action against a third party for the past infringement of the marks identified in the Pending Trademark Applications, including the right to collect damages for past infringement.
3. Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Pending Trademark Applications.

IN WITNESS WHEREOF, the undersigned parties represent that they have authority to execute this Agreement and to carry out all obligations imposed hereunder, have read, understand, and agreed to the terms of this Assignment, and have executed this instrument as of the date of full execution of this Assignment.


