CORRECTED SERVICE MARK ASSIGNMENT AGREEMENT

This Service Mark Assignment Agreement ("Assignment"), effective April 5, 2017 ("Effective Date"), is made by and between MERIDIAN BANK ("Assignor"), a Pennsylvania chartered bank having an address at 9 Old Lincoln Highway, Malvern, PA 19355, and MERIDIAN WEALTH PARTNERS, LLC ("Assignee"), a Pennsylvania limited liability company having an address at 1000 Germantown Pike, Suite H-1, Plymouth Meeting, PA 19462.

WHEREAS, Assignor is the applicant in pending U.S. Application Serial No. 87/255,204, filed in the United States Patent and Trademark Office ("USPTO") on December 2, 2016 on an "Intent to Use" basis, for the mark "MERIDIAN WEALTH PARTNERS" ("Mark") for financial advisory and consultancy services, financial planning and investment advisory services, and financial services, namely, wealth management services; and

WHEREAS, Assignor wishes to assign all of its right, title and interest in and to the Mark, including its right, title and interest in and to U.S. Application Serial No. 87/255,204, to Assignee, and Assignee wishes to accept same; and

WHEREAS, Assignee is a wholly owned subsidiary of Assignor and the successor of Assignor to that portion of the ongoing and existing business to which the Mark pertains; and

WHEREAS, Assignor previously caused a form of this Agreement to be filed which, by a typographical error, erroneously listed the above Effective Date as April 5, 2015, rather than the true effective date of April 5, 2017 (which latter accurate Effective Date was, however, set forth in the Cover Sheet of such prior filing); and

WHEREAS, by this instant Agreement the parties hereto wish to correct such typographical error;

NOW, THEREFORE, for one dollar and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties hereto agree as follows:

1. Incorporation of Recitals. The foregoing recitals are incorporated herein by reference and made a part hereof.

2. Assignment. As of the above Effective Date, Assignor unconditionally and irrevocably assigns, sets over and transfers to Assignee all of Assignor's right, title and interest in and to the Mark, worldwide, including but not limited to all right, title and interest in and to the Mark in the United States of America, including U.S. Application Serial No. 87/255,204, and all good will of the business symbolized by the Mark, together with all claims for past infringement of said Mark, the right to sue for and collect for all damages and profits arising from past infringement of said Mark, and all sums that may be recovered for past infringement of said Mark. U.S. Application Serial No. 87/255,204 is being assigned as part of the portion of the ongoing and existing business transferred from Assignor to Assignee to which the Mark pertains. Assignee hereby accepts such assignment.

3. Applicable Law. Federal law will control the interpretation of this Agreement and where it is not applicable, Pennsylvania law shall control. If any part of this Agreement shall be ruled invalid, its other parts shall remain in full force and effect.
