5. The executed Agreement of Merger between the aforesaid constituent companies is on file at an office of the aforesaid surviving limited liability company, the address of which is as follows:

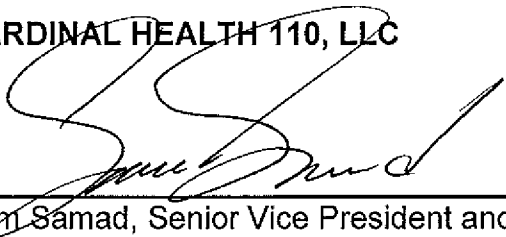

7. The Agreement of Merger between the aforesaid constituent companies provides that the merger shall be effective on January 1, 2017 at 12:01am EST.

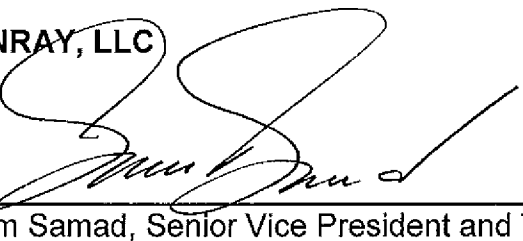
