TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is entered into as of June 23, 2017, by Marquette Capital Fund I, LP, a Delaware limited partnership (the "Lender"), for itself and as agent for the other purchasers party to the Securities Purchase Agreement.

Natural American Foods, Inc., a Delaware corporation (the "Borrower") and the Lender are party to, among other things, a Trademark Security Agreement dated as of December 31, 2013, whereby the Borrower granted the Lender a security interest in the Trademark Collateral as defined therein, including the Trademarks set forth in Schedule 1 hereto (the "Trademark Agreement").

The Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on February 4, 2014, at Reel 005207, Frame 0762.

The Borrower has requested that the Lender release its security interest in the Trademark Collateral.


ACCORDINGLY, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. As used herein, terms defined in the Trademark Agreement and not otherwise defined herein have the meanings given them in the Trademark Agreement.
2. The Lender hereby irrevocably releases its security interest in the Trademark Collateral, including without limitation the Trademarks set forth on Schedule 1 hereto.
3. Subject to other security interests, if any, granted by the Borrower to other financial institutions, the Lender hereby reassigns, grants and conveys to the Borrower, without any representation, warranty, recourse or undertaking by the Lender, all of the Lender's right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks set forth on Schedule 1 hereto.
