Kaneka-Atrium Trademark Assignment

This trademark assignment is by and between Kaneka Corporation formed in accordance with the laws of Japan and Atrium Medical Corporation, a corporation formed in accordance with the laws of Delaware. This agreement shall be effective on August 4, 2017 (Effective Date).

Atrium certifies that they are the owner of all right, title and interest in and to the trademarks and the corresponding registrations set forth on Exhibit I (collectively, the "Trademarks"), together with the goodwill of the business connected with and symbolized by the Trademarks. Atrium also certifies that they have not executed any agreements that would be in conflict with the agreement that they are now entering into.

Atrium hereby sells, assigns, transfers and conveys to Kaneka the entire right, title, interest in and to the Trademarks in the United States together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to renew in Kaneka's name any registrations in the Trademarks, the right to apply for trademark registrations within or outside the United States for the Trademarks, and any priority right that arises from the Trademarks). Atrium further agrees to cease all use of the Trademarks after the Effective Date of this Agreement.

Kaneka agrees to pay Atrium \$5,000 (U.S.) as compensation for this agreement. Atrium agrees to this compensation and that it will make no claim to receive any additional payment, royalties, or any other form of compensation at any time in the future.

Atrium authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration set forth on Exhibit I to Kaneka as assignee of Atrium's entire right, title and interest therein. Atrium agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Kaneka's ownership of the Trademarks.

This agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.

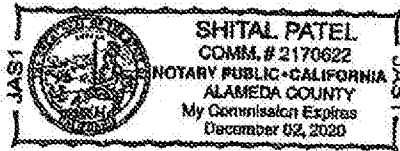
