## TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is entered into as of June 23, 2017, by HC Capital Holdings 0909A, LLC, a Delaware limited liability company (the "Lender").

Natural American Foods, Inc., a Delaware corporation (the "Borrower") and the Lender are party to, among other things, a Trademark Security Agreement dated as of December 31, 2013, whereby the Borrower granted the Lender a security interest in the Trademark Collateral, as defined therein, including the Trademarks set forth in Schedule 1 hereto (the "Trademark Agreement").

3. Subject to other security interests, if any, granted by the Borrower to other financial institutions, the Lender hereby reassigns, grants and conveys to the Borrower, without any representation, warranty, recourse or undertaking by the Lender, all of the Lender's right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks set forth on Schedule 1 hereto.
