## TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is entered into as of June 23, 2017, by Marquette Capital Fund I, LP, a Delaware limited partnership, in its capacity as agent for the Secured Parties (the "Agent").

Natural American Foods, Inc., a Delaware corporation (the "Grantor") and the Agent are party to, among other things, a Trademark Security Agreement dated as of December 1, 2015, whereby the Grantor granted the Agent a security interest in the Trademark Collateral, as defined therein, including the Trademarks set forth in Schedule 1 hereto (the "Trademark Agreement").

The Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on March 28, 2016, at Reel 005758, Frame 0800.

1. As used herein, terms defined in the Trademark Agreement and not otherwise defined herein have the meanings given them in the Trademark Agreement.
2. The Agent hereby irrevocably releases its security interest in the Trademark Collateral, including without limitation the Trademarks set forth on Schedule 1 hereto.
3. Subject to other security interests, if any, granted by the Grantor to other financial institutions, the Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, all of the Agent's right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks set forth on Schedule 1 hereto.
