RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”), dated as of August 7, 2017, is made by ALLY BANK (“Agent”).

WHEREAS, pursuant to that certain Grant of Security Interest in Trademarks, dated October 31, 2014 (the “Trademark Agreement”), SILICON TURNKEY SOLUTIONS, INC. (“Grantor”) granted to Agent, on behalf of itself and the Lenders (as defined in the Trademark Agreement) a security interest in certain Registered Trademarks (as defined in the Trademark Agreement) of Grantor, which Registered Trademarks are more fully identified on Schedule A annexed hereto and made a part hereof.

WHEREAS, Agent’s security interest was recorded with the United States Patent and Trademark Office (“USPTO”) by Grantor’s filing of the Trademark Agreement which was recorded with the USPTO on November 7, 2014, at Reel 5402, Frame 0347.

NOW THEREFORE, Agent hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges the Trademark Agreement and Agent’s security interest in, lien on, and conditional assignment of the Registered Trademarks and Agent hereby reassigns to Grantor any and all such right, title and interest (if any) that the Agent may have in the Registered Trademarks. Agent hereby authorizes the recordation of this Release with the USPTO. Agent agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Agent’s security interest in the Registered Trademarks and the termination of the Trademark Agreement. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law principles (but including and giving effect to Sections 5-1401 and 5-1402 of the New York General Obligations Law).
