FIRST: That the Parent owns 100% of the issued and outstanding shares of the capital stock of **RFL Electronics Inc.** (the "Subsidiary"), a Delaware corporation organized on October 26, 1992.

RESOLVED FURTHER, that any officer of the Parent be, and each of them hereby is, authorized and empowered, in the name and on behalf of the Parent, to execute and file a Certificate of Ownership and Merger with the Delaware Secretary of State, and to pay all requisite fees in connection therewith.

THIRD: That the Merger and this Certificate of Ownership and Merger has been adopted, approved, certified, executed and acknowledged by the Parent in accordance with the laws of the State of Delaware.

FOURTH: That the Merger shall become effective on October 1, 2016.
