**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

WHEREAS, Heckmann Water Resources Corporation, a Texas Corporation and Thermo Fluids Inc., a Delaware corporation, each an affiliate of Nuverra Environmental Solutions, Inc. (the "Companies") entered into a Patent and Trademark Security Agreement, dated as of April 10, 2012 (as heretofore amended, modified, supplemented or amended and restated, the "Security Agreement") among the Companies, the other grantors party thereto and Wells Fargo Bank, National Association, as Administrative Agent (the "Administrative Agent") pursuant to which each Company granted a security interest (the "Security Interest") in all of such Company's right, title and interest in and to the Trademarks (as defined in the Security Agreement), including, without limitation, the trademark registrations and trademark applications set forth on the attached Schedule A (the "Trademarks"), all to the extent set forth in the Security Agreement; and

WHEREAS, a Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office on May 1, 2012 at Reel 4768 and Frame 0565.


WHEREAS, the Company has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the relinquishment and discharge of its security interest in and to the Trademarks; and

WHEREAS, all of the obligations secured by the Security Interest have been fully paid and/or deemed satisfied and the Administrative Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, without warranty or recourse of any kind; hereby releases its Security Interest held in the Trademarks, including without limitation the trademark registrations and trademark applications set forth on the attached Schedule A annexed hereto, and hereby, (i) terminates all its rights, powers, privileges and remedies under the Security Agreement with respect to the Trademarks, (ii) re-conveys, re-transfers and sets over to each Company (including Nuverra Environmental Solutions, Inc.) any right, title or interest that the Administrative Agent may have acquired in the Trademarks, together with all the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Security Agreement related to the Trademarks.
