ASSIGNMENT OF UNITED STATES TRADEMARKS

WHEREAS, pursuant to a certain Contribution Agreement, dated September 1, 2015 (the "Contribution Agreement"), the Assignee has acquired the rights to all of the assets of the Assignor, and in furtherance of the Contribution Agreement the Assignor desires to evidence the assignment to Assignee of the entire interest of Assignor in and to the Marks, including all federal and state registrations thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns to Assignee all of Assignor's right, title, and interest, including all common law and statutory rights, and any and all federal and state registrations, in and to the Marks, together with (i) all of the goodwill and the business symbolized by the Marks, and (ii) all causes of action, claims, and demands or other rights for, or arising from, any infringement, including past infringements, of the Marks. The Assignor shall not, at any time after the date hereof, claim any right, title or interest to the Marks.

2. Assignor further agrees, without further consideration, to perform such other lawful acts and execute such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner or proprietor of each of the rights hereby conveyed.

3. Subject to the terms hereof, Assignee hereby accepts such assignment of the Marks.
