**CONFIRMATION OF
TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Confirmation of Termination and Release of Security Interest in Trademarks is granted and conveyed as of August 9, 2017 by and among STG III, L.P., a Delaware limited partnership having a business address at 2475 Hanover Street, Palo Alto, CA 94304, as agent (in such capacity and any successor in such capacity, the "Agent") for the Lenders (as defined in the Security Agreement referred to below), in favor of Symphony Health Solutions Corporation, a Delaware corporation and Source Healthcare Analytics, LLC., a Delaware limited liability company (collectively, the "Grantors").

WHEREAS, pursuant to the Security Agreement, dated as of May 29, 2015, made by the Grantors in favor of the Agent (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that Intellectual Property Security Agreement, dated as of May 29, 2015, among the Agent and Grantors (the "Intellectual Property Security Agreement"), by reference to the Security Agreement, pursuant to which Grantors reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral, including all of those marks identified on **Exhibit A** (the "Trademarks"), together with all the goodwill of Assignors associated with and represented by the Trademarks, and the registration thereof (collectively, the "Trademark Collateral").

WHEREAS, the Trademark Division of the United States Patent and Trademark Office recorded the Intellectual Property Security Agreement against the Trademark Collateral at Reel 5571/ Frame 0028 on July 7, 2015; and

WHEREAS, the Agent terminated and released the entirety of its Security Interest in all collateral, including the Trademark Collateral, pursuant to the Loan Payoff Confirmation Letter, dated as of April 20, 2016 ("Loan Payoff Letter");

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which the parties hereby acknowledge, and upon the terms set forth in this Confirmation of Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademarks" shall have the meaning provided by reference in the Intellectual Property Security Agreement.

2. Release of Security Interest. The Agent hereby confirms that the Loan Payoff Letter terminated, released, discharged, and relinquished all security interests granted pursuant to the Intellectual Property Security Agreement with respect to all of the Trademarks and the Trademark Collateral related or associated with such Trademarks. Notwithstanding the foregoing, to the extent it is deemed that the Loan Payoff Letter did not effect such termination, release, discharge, and relinquishment, with this document the Agent hereby terminates, releases, discharges, and relinquishes all security interests granted pursuant to the Intellectual Property Security Agreement with respect to all of the Trademarks and the Trademark Collateral related or associated with such Trademarks. Assignee specifically acknowledges that all such security interests are no longer effective, and that Assignee does not own any rights to or have any ownership interest in the Trademarks and the Trademark Collateral related or associated with such Trademarks.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.


