Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation (the "Corporation") adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation of January 31, 2014 ("Articles of Incorporation"):

First: The name of the Corporation is Cross Optical Group, Inc.

Second: The amendment to the Articles of Incorporation is as follows: ARTICLE I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE I. NAME

The name of the corporation shall be Costa Del Mar, Inc."

Third: The foregoing amendment of the Articles of Incorporation was approved as of the 14th day of April, 2014, by written consent of the sole shareholder and the number of votes cast for the amendment was sufficient for approval.

Fourth: Except as modified hereby, the Articles of Incorporation of the Corporation shall be and remain in full force and effect.
