RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 9, 2017 (this "Trademark Release"), is made by Wells Fargo Bank, National Association, as Secured Notes Collateral Agent for the holders of the Secured Obligations, in favor of Cornerstone Chemical Company, a Delaware corporation (the "Issuer").

WITNESSETH:

WHEREAS, the Issuer is party to that certain Indenture, dated as of March 8, 2013 (including all annexes, exhibits, or schedules thereto, and as amended, restated, supplemented or otherwise modified from time to time, the "Indenture"), by and among the Issuer, H.I.G. BBC Holdings Corp., a Delaware corporation ("Holdings"), and Wells Fargo Bank, National Association, as trustee and as Secured Notes Collateral Agent;

WHEREAS, pursuant to the Indenture, the Issuer, Holdings and the Secured Notes Collateral Agent entered into that certain Pledge and Security Agreement, dated as of March 8, 2013 (including all annexes, exhibits, or schedules thereto, and as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"; capitalized term used but not otherwise defined herein have the meanings given to them in the Security Agreement);

WHEREAS, pursuant to the Security Agreement, the Issuer executed the Grant of Security Interest in Trademarks, dated as of March 8, 2013 (the "Trademark Security Agreement"), pursuant to which the Issuer granted to the Secured Notes Collateral Agent, for the benefit of the holders of the Secured Obligations, a security interest in and continuing lien on all of the Issuer's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on March 8, 2013, at Reel 4978 and Frame 0608; and

WHEREAS, in accordance with the terms of the Certificate of Satisfaction and Discharge and the Release of Liens and Release of Guarantee, each dated on the date of this Trademark Release, the Issuer has satisfied and fulfilled all of its obligations to release the Secured Notes Collateral Agent's security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Secured Notes Collateral Agent agrees as follows:

1. The Secured Notes Collateral Agent, without recourse, representation or warranty of any kind, hereby terminates, releases and discharges its security interest in and continuing lien on all of the Borrower's right, title and interest in and to the Trademark Collateral, along with all goodwill associated therewith, including the Trademarks set forth on Schedule A attached hereto.


2. The Secured Notes Collateral Agent hereby authorizes the Borrower and its respective counsel (including its respective designees) to file this Trademark Release with the U.S. Patent and Trademark Office.

3. The Secured Notes Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
