Assignor hereby authorizes any official of any country empowered to issue trademarks to record this Assignment, and to issue or transfer the Marks to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.

Assignor represents and warrants that Assignor has the full right to convey the entire right, title, and interest herein assigned, that there are no outstanding rights, title, or interests inconsistent with those assigned herein, and the Assignor will not execute any instrument or grant or transfer any rights, title, or interests inconsistent with the rights, title, and interests assigned herein.
