Trademark Alienation Contract

Joint-Stock Company "OBR" (formerly OJSC "Orkla Brands Russia"), represented by the General Director Miller Fedor Alexandrovich acting on the basis of the Charter, hereinafter referred to as the "Rightholder", on the one party,

and Limited Liability Company "N.K. Krupskaya Confectionery Factory" represented by the Head of Administration of LLC "Managing Company "Slavyanka" Sogulyak Evgeny Ivanovich, performing the functions of the sole executive body of LLC "N.K. Krupskaya Confectionery Factory", acting on the basis of the Company's Charter, the Contract on the Exercise of the Powers of the Company's Sole Executive Body dd April 18, 2016, hereinafter referred to as the "Assignee", on the other party,

considering that the Rightholder has all the rights to the Trademark registered under No. 4243642 with priority from February 17, 2012, and the Assignee wishes to acquire, under the terms of this Contract, the right to the above trademark in respect of goods of Class 30 of the International Classification of Goods and Services (ICGS), have agreed the following:

1. Subject of Contract

The Rightholder grants to the Assignee all rights to a trademark with pictorial and verbal elements registered under the number 4243642 with priority from February 17, 2012 according to the application under a serial number 85545817 filed with the US Patent and Trademark Office (hereinafter referred to as the "Trademark") with respect to all goods of Class 30 of ICGS: Candies; Chocolate; Taffies.

2. Price and Payment Procedure

The total value of this Contract is 3 500 000,00 (Three Million Five Hundred Thousand) Rubles 00 Kopecks, including VAT 533 898,31 (Five Hundred Thirty Three Thousand Eight Hundred Ninety Eight) Rubles 78 Kopecks.

Remuneration is paid by the Assignee to the settlement account of the Rightholder within 3 (three) banking days after the date of signing the Universal Transfer Instrument (UTI) for the transfer of exclusive rights to trademarks.

The Assignee shall pay all duties, levies, taxes and other expenses connected with the conclusion and registration of an alteration of the Owner.

3. Registration of Alteration of the Owner

The Assignee pays the fixed fee for the registration of an alteration of the Owner in accordance with this Contract. The Assignee must submit to the US Patent and Trademark Office a package of documents for amendments to the indication of the owner of the Trademark.

These actions must be performed within 30 (thirty) banking days from the date of signing by the parties of this Contract.

Rights to the Trademark shall be transferred to the Assignee in full, from the time recording of the Assignee as the owner of the Trademark to the Register by the US Patent and Trademark Office.
