1. I am President of Mountain Pure, LLC ("Assignee" or "Mountain Pure"), of Little Rock, Arkansas, competent to testify upon personal knowledge as to all facts set forth herein.
2. The services for which REALPURE BRAND (& design) (the "Mark") is in use in commerce include fruit flavored drinks containing water and fruit juices; noncarbonated fruit juice drink containing water; syrups for use in the manufacture of soft drinks; concentrates for making fruit flavored drinks with water; whipped fruit drinks containing water for consumption on or off the premises; and carbonated and non-carbonated isotonic electrolyte beverages.


