CONFIRMATORY ASSIGNMENT OF TRADEMARKS

This Confirmatory Assignment of Trademarks is made as of July 11, 2017, by and between IHS Global Canada Limited., a corporation existing under the laws of the Province of Alberta, Canada (“Seller”) and Sphera Solutions, Inc., a Delaware corporation (“Company”).

Whereas, Seller and Diamondback Acquisition, Inc. (“Diamondback”) entered into that certain Asset Purchase Agreement dated April 27, 2016, (the “APA”) pursuant to which Seller conveyed to Diamondback all of its right, title and interest in and to its Operational Excellence and Operational Risk Management divisions, (“Business”);

Whereas, as part of Seller’s conveyance of all of its right, title and interest in and to the trademarks owned by Seller and affiliated with the Business, shown on Schedule A, and the goodwill of the business in connection therewith (the “Trademarks”);

Whereas, pursuant to Transfer Pricing Key Schedules dated June 3, 2016, Diamondback conveyed all right, title and interest in and to all intellectual property to OERM Software, Inc. (“OERM”);

Whereas, pursuant to the State of Delaware Certificate of Amendment of Certificate of Incorporation, dated June 21, 2016, OERM changed its name to Sphera Solutions, Inc.; and

Whereas, Seller and Sphera wish to clarify that Schedule A lists the transferred Trademarks in and to which all right, title and interest were effectively and irrevocably transferred from Seller to Diamondback, Seller and Sphera agree as follows:

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, the Parties agree as follows:

1. All capitalized terms not defined herein shall have the meaning set forth in the APA. To the extent of any conflict between the terms of this Confirmatory Assignment of Trademarks and the APA, the terms of the APA will prevail and control.
2. Seller hereby agrees and acknowledges that all of its right, title and interest in the Trademarks was transferred to Diamondback pursuant to the APA. Seller hereby agrees and acknowledges that Schedule A lists the transferred Trademarks. Seller further agrees and acknowledges that neither it, nor any of its affiliates, hold any right, title or interest in or to the Trademarks or any other intellectual property rights relating to the Business.
3. Seller agrees to execute such additional documents as Sphera reasonably requests to register and otherwise give full effect to the rights of Sphera under this Confirmatory Assignment of Trademarks in and to the Trademarks worldwide, including all documents necessary to record in the name of Sphera the assignment of the Trademarks with the United States Patent and Trademark Office and trademark offices in other jurisdictions.




