WHEREAS, for good and valuable consideration, the receipt and adequacy of which were hereby acknowledged, the parties had agreed, *inter alia*, as follows:

Assignment. Assignor granted, bargained, transferred, sold, assigned, conveyed and delivered to Assignee its entire right, title and interest in and to the Mark, including any pending applications in the U.S. or abroad, and all goodwill appurtenant therewith, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made, together with all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for damages, and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representatives.

Assignor further covenanted and agreed that, at any time and from time to time after February 19, 2016, upon the written request of Assignee, it would do, execute, acknowledge and deliver or cause to be done, executed, acknowledged and delivered, each and all of such further acts, deeds, assignments, transfers, conveyances, powers of attorney and assurances as reasonably required by Assignee in order to assign, transfer, set over, convey, assure and confirm unto and vest in Assignee, its successors and assigns, title to the assets sold, conveyed, transferred and delivered by this Agreement.

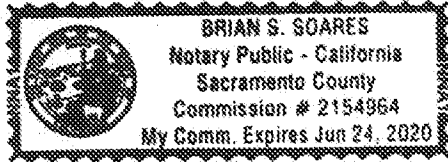
