**TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT AND
RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this
"Release"), dated as of 8/11/17, is made by and among Silicon Valley Bank ("Bank"), in favor of
LowerMyBills, Inc. (the "Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated as of April 4, 2000 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on July 20, 2000 at Reel/Frame No. 002105/0330, the Grantor granted the Bank a Lien on and continuing security interest in, all of its right, title and interest in, to and under the "Collateral" (as defined therein) pledged by the Grantor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks;

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Bank; and

WHEREAS, the Grantor has requested that the Bank release its Lien on and continuing security interest in, all right, title and interest of the Bank in and to the Collateral.


NOW, THEREFORE, the Bank, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its Lien on and continuing security interest in the Collateral, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and any and right, title and interest of the Bank in the Collateral shall hereby terminate, cease and become void.

The Bank agrees to provide the Grantor with any information and additional authorization and documentation reasonably necessary to effect the release of the Bank's security interest in the Collateral (without recourse, representation or warranty and at the Grantor's sole cost and expense).
