Pursuant to Section 253 of the General
Corporation Law of the State of Delaware

Pursuant to Section 253 of the Delaware General Corporation Law (the "DGCL"), Match Group, Inc. (the "Corporation"), a Delaware corporation, does hereby certify to the following information relating to the merger (the "Merger") of Hatch Labs, Inc., a Delaware corporation (the "Subsidiary"), with and into the Corporation, with the Corporation remaining as the surviving corporation.

FIRST: The Corporation is incorporated pursuant to the DGCL. The Subsidiary is incorporated pursuant to the DGCL.

SECOND: The Corporation owns all of the outstanding shares of each class of capital stock of the Subsidiary.

THIRD: On July 13, 2017, the Board of Directors of the Corporation adopted, by unanimous written consent of the members thereof, resolutions, which, among other things, approved the Merger pursuant to Section 253 of the DGCL. The resolutions to so merge are set forth on Exhibit A hereto.

FOURTH: The Corporation hereby merges the Subsidiary with and into the Corporation.

FIFTH: The Corporation shall be the surviving corporation of the Merger and shall continue under the name "Match Group, Inc."


SIXTH: The Certificate of Incorporation of the Corporation, as amended, as in effect immediately prior to the Merger shall be the Certificate of Incorporation of the Corporation immediately following the Merger.
