RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”), dated as of August 15, 2017, is made by **GOLUB CAPITAL LLC**, a Delaware limited liability company, in its capacity as administrative agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacity, “Administrative Agent”) and is as follows:

WHEREAS, **SYNCHROGENIX INFORMATION STRATEGIES, LLC**, Delaware limited liability company partnership (successor in interest to Synchronix Information Strategies Inc., Delaware corporation, “Grantor”), and the Administrative Agent were party to that certain Trademark Security Agreement dated as of April 2, 2014 (the “Agreement”; capitalized terms used but not defined herein will have the meaning given to them in the Agreement), which was recorded with the United States Patent and Trademark Office on April 7, 2014, in its records at Reel 5252, Frame 0491;

WHEREAS, the Agreement granted to the Administrative Agent a security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral, including, without limitation: (a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I); (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; (c) all products and all proceeds (as that term is defined in the Code) of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License; and

WHEREAS, Administrative Agent desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby (i) fully and finally releases and terminates (a) its security interest and other rights in, to and under the Trademark Collateral and (b) any and all other rights it may have under the Agreement and (ii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence release and termination of its rights under each of the Loan Documents with respect to the Trademark Collateral.
