**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST, dated as of August 15, 2017 (this “Release”) is made by Ares Capital Corporation, a Maryland corporation, acting in its capacity as administrative agent (in such capacity, the “Administrative Agent”) under that certain Guaranty and Security Agreement, dated as of December 1, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and between Urgent Cares of America Holdings I, LLC, a Delaware limited liability company (the “Company”), the other Grantors party thereto and the Administrative Agent.

WHEREAS, pursuant to the Security Agreement, the Company granted to the Administrative Agent a continuing security interest in all of the Company’s right, title, interest and associated goodwill in the trademarks set forth on the attached Schedule I (the “Trademark Collateral”);

WHEREAS, pursuant to the Security Agreement, the Company and the Administrative Agent executed the Trademark Security Agreement, dated as of December 1, 2015, which was recorded in the records of the United States Patent and Trademark Office on December 1, 2015 at reel 5679, frame 0172; and


WHEREAS, the Company has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral.


