FIRST: The name of the limited liability company is CVP Group, LLC.

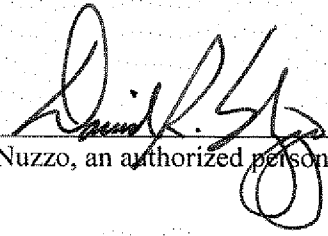
SECOND: The Original Certificate of Formation is hereby amended by amending Article I thereof so that, as amended, said Article I shall be read as follows:
