**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (this “Termination”), dated as of August 17, 2017, is executed by JPMORGAN CHASE BANK, N.A., as Administrative Agent (“Administrative Agent”), in favor of SHUTTERFLY, INC., a Delaware corporation (“Borrower”). All capitalized terms used in this Termination and not otherwise defined herein shall have the respective meanings given to such terms in the Security Agreements (defined below).

RECITALS

A. Pursuant to (i) that certain Confirmatory Grant of Security Interest in United States Trademarks, dated as of April 28, 2008 (the “2008 Security Agreement”), by and between Borrower and Administrative Agent, (ii) that certain Trademark Security Agreement, dated as of November 22, 2011 (the “2011 Security Agreement”), by and between Borrower and Administrative Agent and (iii) that certain Trademark Security Agreement, dated as of June 10, 2016 (the “2016 Security Agreement” and together with the 2008 Security Agreement and the 2011 Security Agreement, the “Security Agreements”), by and between Borrower and Administrative Agent, Borrower granted to Administrative Agent security interests in the IP Collateral (defined below).

B. The Security Agreements were recorded with the Trademark Division of the United States Patent and Trademark Office on April 29, 2008 at Reel/Frame 3768/0519, on December 7, 2011 at Reel/Frame 4673/0614 and on June 15, 2016 at Reel/Frame 5814/0405 to evidence the security interests granted under the Security Agreements.

C. Administrative Agent is executing this Termination in order to evidence the termination and release of its security interests in the IP Collateral.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates and releases all of Administrative Agent’s rights, titles and interests in, to and under the following items that were granted to Administrative Agent through the Security Agreements (collectively, the “IP Collateral”):

(i) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I (the “Trademarks”);

(ii) all goodwill associated with or symbolized by the Trademarks; and

(iii) all assets, rights and interests that uniquely reflect or embody the Trademarks.


(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination. Except as expressly provided in the preceding sentence, the execution and delivery of this termination and release and any further documents and the performance of any actions by Administrative Agent are made without representation or warranty by, or recourse to, Administrative Agent.

(c) Administrative Agent authorizes and requests the trademark division of the United States Patent and Trademark Office to record this Termination and agrees to take further actions, as reasonably requested by Borrower, to evidence the release and termination of Administrative Agent's security interests in the Trademarks provided for herein, in each case at the sole expense of Borrower.
