NOW, THEREFORE, in consideration of the mutual covenants and promises set forth in this Assignment and the Contribution Agreement, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby contributes, assigns, transfers and conveys to Assignee, and Assignee hereby assumes, all right, title and interest in, to and under (i) the Trademarks in the United States and throughout the world, together with the goodwill of the business connected with and symbolized by the Trademarks, and including, without limitation, all registrations and applications therefor, the right to renew any registrations for the Trademarks, the right to apply for trademark registrations within or outside of the United States, any priority right that may arise from the Trademarks, and the right to sue for past, present and future infringement or dilution of the Trademarks and to collect and retain all damages and profits related to the foregoing, and and (ii) the Patents in the United States and throughout the world, and including, without limitation, all reissues, extensions, divisionals, continuations, continuations-in-part, and reexaminations thereof, the right to maintain any issued Patents, the right to apply for patents within or outside of the United States based on the claims of any of, or claiming priority to any of, the Patents, the right to sue for past, present and future infringement of the Patents and to collect and retain all damages and profits related to the foregoing, in each of (i) and (ii), for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment not been made.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but which together shall be deemed one and the same instrument, and a facsimile copy of such execution shall be deemed an original.
