ASSIGNOR represents that at the time of execution of this Trademark Assignment, ASSIGNOR is the owner of all right, title and interest in and to the Trademarks and Registrations and that ASSIGNOR has not assigned, transferred, licensed or encumbered ASSIGNOR'S rights therein, and that ASSIGNOR will not hereafter assign or attempt to assign any rights therein, or take any other action inconsistent with this Trademark Assignment.

ASSIGNOR agrees to execute such further documents and take such acts as reasonably required by ASSIGNEE or ASSIGNEE'S successor to secure and enforce ASSIGNEE's rights in the Trademarks and Registrations, including, but not limited to, further assignments.




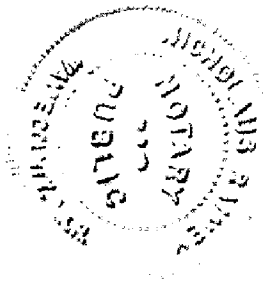
