RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is given as of August 14, 2017, by SUNTRUST BANK, as Administrative Agent (the “Administrative Agent”), to Cook Maran & Associates, Inc., a New York Corporation located at 461 Pantigo Road, East Hampton, New York 11937 (the “Grantor”).

WHEREAS, on May 31, 2016, the Grantor, certain other parties thereto and the Administrative Agent entered into a Pledge and Security Agreement (the “Security Agreement”) and a Grant of Security Interests Patents and Trademarks (the “Trademark Security Interest”);

WHEREAS, pursuant to the Security Agreement and Trademark Security Interest, the Grantor granted to the Administrative Agent, among other collateral, a security interest in all of the Grantor’s right, title and interest in, to and under the United States trademark listed on the attached Schedule A (the “Trademark”);

WHEREAS, the Trademark Security Interest was recorded in the United States Patent & Trademark Office on June 2, 2016 at reel/frame 5805/0648; and


WHEREAS, the Administrative Agent wishes to release its security interest in the Trademark and retransfer and reassign to the Grantor, in each case without recourse, representation or warranty of any kind, (i) all of the Administrative Agent’s right, title and interest in and to the Trademark, together with (ii) all Proceeds (as such term is defined in the Pledge and Security Agreement) of the Trademark, (iii) all the goodwill of the businesses with which the Trademark is associated, and (iv) all causes of action arising prior or after the date hereof for infringement of the Trademark or unfair competition regarding the same (collectively, the “Trademark Collateral”).

NOW THEREFORE, the Administrative Agent hereby releases, discharges and terminates any security interest it may have in the Trademark Collateral, and reassigns any and all right, title and interest it may have in and to the Trademark Collateral, in each case without recourse to, or representation or warranty of any kind from, the Administrative Agent.
