CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, Texas Rangers Baseball Partners, a Texas general partnership, with offices at 1000 Ballpark Way, Arlington, Texas 76011 ("Assignor"), owned the following TEXAS (Stylized) mark  (the "Mark") and Application Serial No. 85/102,260 (the "Application"), which was later granted registration as shown in U.S. Reg. No. 3,957,167 (the "Registration") and is the record owner of the Registration;

WHEREAS, Assignor assigned to Rangers Baseball LLC, a Delaware limited liability company, with offices at 1000 Ballpark Way, Arlington, Texas 76011 ("Assignee"), Assignor's trademarks and service marks as set forth on Schedule A to the Trademark Assignment Agreement executed by Assignor and Assignee on August 12, 2010, with an effective date as of August 12, 2010;

WHEREAS, Assignor intended to assign to Assignee all marks, applications and registrations comprising or containing the word TEXAS among others, including all of Assignor's right, title and interest in the Mark and Application, together with the goodwill of the business symbolized thereby as of August 12, 2010, but the Mark and Application were inadvertently and unintentionally omitted from Schedule A to the Trademark Assignment Agreement executed by Assignor and Assignee on August 12, 2010;

WHEREAS, Assignor was subsequently dissolved;

WHEREAS, Major League Baseball Properties, Inc. was the Agent for the Assignor until its dissolution and as such has the authority to execute this Confirmatory Assignment that is effective as of the date of the Trademark Assignment Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of

which is hereby acknowledged, Major League Baseball Properties, Inc. does hereby confirm that, as of August 12, 2010, the Assignor intended to assign and did assign and transfer to Assignee, its successors and assigns, absolutely and forever, its entire right, title and interest, whether statutory or at common law, in and to the Mark and the Registration, together with the goodwill of the business symbolized thereby, all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.
