TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is entered into this 21 day of _____, 2017 (the "Effective Date") by Device Expert Inc., a corporation formed under the International Companies Act of Samoa ("Assignor") and by Fast Track Global Limited, a company formed under the International Companies Act of Samoa ("Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to certain U.S. trademarks marks, both registered and unregistered, and applications for trademark and service mark registrations filed with the United States Patent and Trademark Office, as listed on Schedule A attached hereto and incorporated herein (together with the goodwill of the business associated therewith (the "Marks")); and

WHEREAS Assignee desires to acquire all of Assignor's right, title and interest, in and to the Marks together with all the goodwill of the business symbolized thereby, and Assignor desires to assign all such right, title and interest in and to the Marks to Assignee, upon the terms and conditions set forth herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by Assignor, the parties agree as follows:

1. Assignor hereby conveys and assigns to Assignee, and Assignee hereby accepts from Assignor, all of Debtor's right, title and interest in and to the Marks, together with any applications and registrations therefor, throughout the world.
2. Assignor represents and warrants that Assignor has all authority necessary to enter into this Agreement and the execution and delivery of this Agreement has been duly and validly authorized.
3. At any time, and from time to time after the Effective Date, at the request and the sole expense of Assignee, Assignor shall promptly execute and deliver such documents, and take other acts, as Assignor or its counsel may reasonably request to effectuate the purposes of this Agreement and the Purchase Agreement.
4. After the Effective Date, Assignor agrees to make no further use of the Marks or any mark confusingly similar thereto, anywhere in the world, except as may be expressly authorized by the parties in writing, and Assignor agrees to not challenge Assignee's use or ownership, or the validity, of the Marks.
5. This Agreement shall be binding on and shall inure to the benefit of the parties to this Agreement and their successors and assigns, if any.

6. Miscellaneous.

(a) No modifications of or additions to this Agreement shall have effect unless in writing and properly executed by both parties, making specific reference to this Agreement by date, parties, and subject matter.

(b) This Agreement and the rights and obligations of the parties hereunder shall be governed by and construed in accordance with the laws of the State of Delaware, without regard

to its conflict of laws principles, and shall be enforceable against the parties in the courts of State of Delaware.


(c) This Agreement may be signed by each party separately, in which case attachment of all of the parties' signature pages to this Agreement shall constitute a fully-executed agreement.

(d) Any provision of this Agreement that is invalid, illegal or unenforceable in any jurisdiction shall, as to that jurisdiction, be ineffective to the extent of such invalidity, illegality or unenforceability, without affecting in any way the remaining provisions of this Agreement in such jurisdiction or rendering that or any other provision of this Agreement invalid, illegal or unenforceable in any other jurisdiction.


