

In witness of the foregoing statements, I do hereby affix my signature and the seal of the Company on this 11th day of July 2008.



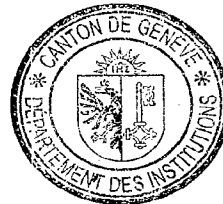
