INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “IP Assignment Agreement”), dated as of June 5, 2017, is by and among, on the one hand, 21st Century Media Newspaper, LLC, a Delaware limited liability company (the “Company”), MediaNews Group, Inc., a Delaware corporation (“MNG”), and 21st Century Media, Inc., a Delaware corporation (the “Parent”, together with the Company and MNG, collectively, the “Assignors”, and each, individually, an “Assignor”), and, on the other hand, Hearst Media Services Connecticut, LLC, a Delaware limited liability company (the “Assignee”). Capitalized terms used but not otherwise defined in this IP Assignment Agreement shall have the meanings given them in the Asset Purchase Agreement, dated as of June 5, 2017, by and between the Company and the Assignee (the “Purchase Agreement”).

WHEREAS, the Assignors are collectively the owner of the entire right, title and interest in, to and under all intellectual property rights arising from or associated with the following, whether protected, created or arising under the laws of the United States or any other jurisdiction: (i) the trade names, trademarks and service marks (registered and unregistered), logos, designs, domain names and other Internet addresses or identifiers, social media identifiers, trade dress and similar rights and applications (including intent to use applications and similar reservations of marks) to register any of the foregoing and all goodwill associated therewith or symbolized by the foregoing identified and set forth on Schedule A attached hereto (collectively, “Marks”); (ii) the patents and patent applications identified and set forth on Schedule B attached hereto (collectively, “Patents”); (iii) all works of authorship and other copyrightable subject matter, whether registered or unregistered, and whether or not published, copyright registrations and applications for registration, and all other corresponding rights, including those copyright registrations identified and set forth on Schedule C attached hereto (collectively, “Copyrights”); (iv) trade secrets, know-how, inventions, discoveries, methods, processes and processing instruments, technical data, specifications, research and development information, technology, databases and other proprietary or confidential information, including rights and licenses, product roadmaps, customer lists and any other information, in each case to the extent any of the foregoing derives economic value (actual or potential) from not being generally known to other Persons who can obtain economic value from its disclosure or use, excluding any Copyrights or Patents that may cover or protect any of the foregoing (collectively, “Trade Secrets”); and (v) moral rights, publicity rights, database rights and any other proprietary or intellectual property rights of any kind or nature that do not comprise or are not protected by Marks, Patents, Copyrights or Trade Secrets (the rights included in subsection (v) herein, together with the Marks, Patents, Copyrights and Trade Secrets, the “Assigned Intellectual Property”).

WHEREAS, pursuant to the Purchase Agreement, the Assignee has agreed to purchase the Purchased Assets, including without limitation, all of each Assignor’s right, title and interest in, to and under the Assigned Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Each Assignor hereby assigns, sells, transfers, grants and conveys to the Assignee, its successors and assigns all of its right, title and interest in and to the Assigned Intellectual Property together with the goodwill of the Business symbolized by the Assigned Intellectual Property, including all rights therein provided by international conventions and treaties, and including, without limitation, the right to sue for, assert claims or demands, settle and/or release, and recover damages and all other remedies, for any past, present or future infringement, misuse, dilution, theft, or misappropriation thereof.

2. Further Assurances.

(a) Within fifteen days after the execution of this IP Assignment Agreement, the Assignors shall deliver to the Assignee all prosecution and registration related documents and information, and all other documents and information reasonably necessary to commence or complete the assignments and recordation of the assignments for (i) the Marks and Patents in the United States Patent and Trademark Office, (ii) the Copyrights in the U.S. Copyright Office, (iii) the applicable domain name registrar(s) and (iv) the officials of corresponding entities or agencies in any applicable jurisdiction, and in each case, shall provide reasonable assistance necessary for the same.

(b) The Assignors hereby request (i) the United States Commissioners of Patents and Trademarks, and the corresponding entities or agencies in any applicable jurisdiction, to record Assignee as the assignee and owner of the Patents and Marks; (ii) the U.S. Copyright Office, and the corresponding entities or agencies in any applicable jurisdiction, to record Assignee as the assignee and owner of the Copyrights; and (iii) any domain name registrars to record Assignee as the assignee and owner of the domain names included in the Assigned Intellectual Property.

(c) The Assignors shall timely execute and deliver any additional documents and perform such additional acts necessary or desirable to permit the Assignee, at its expense, to record and perfect the interest of the Assignee in, to and under the Assigned Intellectual Property and shall not enter into any agreement in conflict with this IP Assignment Agreement.

(d) The Assignors authorize and request the United States Patent and Trademark Office and the United States Copyright Office and/or head of any similar state or foreign entity or agency with jurisdiction over intellectual property to issue all patent, trademark, service mark or copyright registrations included in the Assigned Intellectual Property that may issue on an application for any patent, trademark, service mark or copyright or a portion thereof to the Assignee, its successors and assigns, in accordance with this IP Assignment Agreement.

3. Governing Law. This IP Assignment Agreement shall be governed by and construed in accordance with the laws of the State of New York, without regard to principles of conflicts of law.

4. Construction. This IP Assignment Agreement is delivered pursuant to and is subject to the Purchase Agreement. Nothing contained herein is intended to or shall be construed to modify, alter, amend, expand, interpret, supersede or otherwise change any of the terms, conditions, covenants, warranties, representations, remedies or any other provisions of the Purchase Agreement. In the event of any conflict between the terms of the Purchase Agreement and the terms of this IP Assignment Agreement, the terms of the Purchase Agreement shall prevail.


5. Counterparts. This IP Assignment Agreement may be executed in any number of counterparts, all of which will constitute one and the same instrument.




